
Analysis and Action Taken.

Going through the feedback report submitted by the teachers, it has been observed more than 96% teachers are strongly agreed that curriculum of the institution is flexible and suitable for enrichment, revision and modification based on recent trends and innovative ideas. 34.6% teachers are strongly agreed and 61.5% agreed that they had the freedom to adopt new teaching techniques and strategies for curriculum in the college.






Q. No. 2. The students are disciplined and respect the staff members


